As ATU TURİZM İŞLETMECİLİĞİ ANONİM ŞİRKETİ (hereinafter referred to as “**ATU**” or the “**Company**”), we benefit from some technologies such as cookies, pixels, gifs (the “**cookies**”) in order to enhance your experience during your visits to our online media. The use of these technologies is carried out in accordance with the legislation, including the Turkish Personal Data Protection Law No. 6698 (the “**PDP Law**”) and the General Data Protection Regulation (EU) 2016/679 (“**GDPR**”), which we are subject to.

The purpose of this Cookie Notice is to give you information regarding the processing of personal data obtained when cookies are used by the Website’s users/members/visitors (the “**Data Subject**”) during the operation of ATU’s website (the “**Website**”), which is operated by us. In this Cookie Notice, we want to explain to you what type of cookies we use and for what purposes we used them on our Website, and how you can control those cookies.

As ATU, we may stop using cookies that we use on our website, change their types or functions, or add new cookies to our website. Therefore, we reserve the right to amend the provisions of Cookie Notice, at any time at our discretion. All kinds of changes made on the current Cookie Notice shall come into force upon being published on the Website or any media publicly available. You can find the latest updating date, at the beginning of this Cookie Notice.

What is Cookie?

Cookies are small pieces of data that are saved in your browser when you visit a website. This data allows the website to remember certain information about you, which helps the website provide a better and personalized user experience.

Which Cookies are Used for What Purposes?

In General

As ATU, we use cookies on our Website for various purposes and we process your personal data by means of those cookies. These purposes are mainly as follows:

- **Performing basic functions required for the operation of the Website.** For instance, members who sign in, should not be required to enter passwords again, when visiting different pages on the Website.
- **Analyzing the Website and enhancing the performance of the Website.** For instance, integrating various servers on which the Website operates, determining the number of visitors who visit the

Website, and accordingly, making performance settings or facilitating the process for the visitors to find the things they look for.

- **Enhancing the functionality of the Website and providing ease of use.** For instance, sharing something on the Website, with third-party social media channels; remembering the user name information or search topics of the visitors who visit the Website in any subsequent visits of them.

Your personal data will be processed through the use of essential cookies in accordance with subparagraph (c) of paragraph (2) of Article 5 of the PDP Law (“processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract”) and subparagraph (b) of paragraph (1) of Article 6 of the GDPR (“processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract”).

In addition, your personal data may also be processed based on subparagraph (f) of paragraph (2) of Article 5 of the PDP Law (“Processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject”) and subparagraph (f) of paragraph (1) of Article 6 of the GDPR (“processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data”).

Performance and analytics cookies, on the other hand, will be used based on your explicit consent, in accordance with paragraph (1) of Article 5 of the PDP Law and subparagraph (a) of paragraph (1) of Article 6 of the GDPR (“the data subject has given consent to the processing of his or her personal data for one or more specific purposes”).

As ATU, your personal data, within the scope of the Cookie Policy, will be shared with third parties from whom our Company benefits, our business partners in Turkey and abroad, our shareholders, including but not limited to the Aéroports de Paris Group, our suppliers in Turkey and abroad, and our group companies in Turkey and abroad, limited to the purposes specified above and in compliance with the conditions stipulated in Articles 8 and 9 of the PDP Law and Article 44 of GDPR.

Cookies Used on Our Website

You can find below the different types of cookies we use on our Website.

Types of Cookies by Duration of Use:

On our website, session cookies and persistent cookies are used based on their duration of use.

Session cookies are utilized to maintain the continuity of the session and are deleted when you close your browser. Persistent cookies, on the other hand, are not deleted when the browser is closed and are automatically removed on a specific date or after a certain period.

Types of Cookies by Party:

Whether a cookie is a first-party or third-party cookie depends on whether the cookie is placed by the website or domain being visited. First-party cookies are directly placed by our Website. Third-party cookies, however, are placed by a domain other than the one you are visiting.

Types of cookies by intended use:

Essential Cookies

The use of certain cookies is strictly necessary for the operation of our Website correctly. For instance, identifier cookies that are activated when you log into our Website allow that your active log-in process continues when you pass from one page to another on our Website.

Functionality and Analytics Cookies

Through these cookies, we can analyze your use of our Website and the performance of our Website and improve the services we provide to you. For instance, with these cookies, we can determine which pages our visitors view the most, whether our Site is working properly and possible problems.

As the Data Subject, What Rights You Have?

Based on Article 11 of the PDP Law and GDPR, Data Subjects shall have the following rights,

- To learn whether personal data are processed or not,
- If personal data are processed, to request information in relation thereto,
- To learn the purpose of processing personal data and whether they are used in compliance with the purpose,
- To know the third persons, to whom personal data are transferred in Turkey and abroad,
- In case personal data are processed incompletely or incorrectly, to request the correction thereof and to request that any operation carried out in this context is reported to the third persons, to whom personal data is transferred,
- Despite being processed in compliance with the provisions of the PDP Law and other relevant laws, to request that personal data shall be erased or destructed in the event that the reasons for the processing no longer exist and any operation carried out in this context is reported to the third persons, to whom personal data is transferred,
- To object to the occurrence of a result against the person himself/herself by analyzing the data processed solely through automated systems,
- To claim compensation for the damage arising from the unlawful processing of personal data.

If you send your requests relating to your said rights to us by the methods specified in the “ATU Turizm İşletmeciliği Anonim Şirketi Data Subject Application Form”, available on the web address [www.atu.com.tr], your applications shall be evaluated and finalized as soon as possible and at the latest within 30 (thirty) days. It is essential that no fee shall be charged concerning the requests, however, the Company reserves the right to charge a fee based on the fee tariff determined by the PDP Board or other authorities.

Data Subject undertakes that the information subject to this Cookie Notice, is complete, correct, and up-to-date and that in case of any change in this information, he/she shall update this information immediately. In case the Data Subject fails to provide updated information, the Company shall have no responsibility.

If the Data Subject makes a request rendering the Company unable to use any of his/her personal data, he/she agrees that he/she may not make full use of the operation of the Website and declares that he/she shall bear any responsibility arising out in this context.
